



Re: Annexus Configuration Tool (ACT) v1.8.2.3 Release Notice

To all of our customers and partners;

This bulletin is the official notice of the ACT v1.8.2.3 release.

i3 Annexus Configuration Tool is an IP finder utility for convenient pre- and post-installation management of i3 IP devices, including cameras, encoders and UIO8 control/sensor device.

New Features / Improvements:

- 1. Supports new i3 camera models: M71, M77, H59, and M21 (pending release).
2. Supports i3 Temperature and Access Control terminal: Annexus 19
3. Supports Bitrate adjustments for currently-sold i3 cameras models. This feature allows for quick configuration of a large number of cameras in accordance with the quoted/sold i3 Cloud Backup storage specifications.

Tip: To enable Camera Video Settings, start by selecting a camera model from ALL MODELS drop-down menu and then selecting one or more cameras from the list.



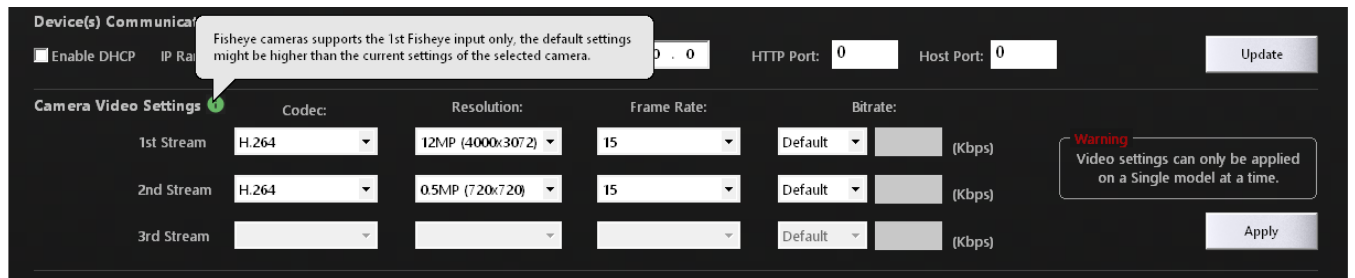
- a. Supported models: Ax19, Ax47, Ax57, Ax63C, Ax67, Ax65W, Ax75RMv2, Ax76, Ax77, Ax78, Ax83C, Ax85, Ax98, M21, H59, M71, M77.
b. The Bitrate adjustment can be done in three ways:
- Default: set the camera to the i3's recommended bitrate setting.
- Best/High/Medium: set the camera to the corresponding i3 Cloud Backup storage bitrate profile, as posted on the i3's Quoting Tool.
- Custom: enter user-preferred bitrate setting for the camera. Note that higher bitrate settings result in improved video appearance but also with increased bandwidth and storage requirements.

Notes:

- Fisheye cameras (E.g., Ax78, Ax98 FW v5.4.5) allow configuring camera video settings, including the bitrate, for the 1st input only (Channel 1). Be mindful of what Mode the Fisheye camera is currently set to as the chosen ACT setting may be higher than the Channel permits in the current mode.



- Bitrate adjustment is not supported for HR16v2, and Ax78/Ax68 FW 5.0.9



**Fixed Issues:**

- Fixed: NCR# 1723 - HR16v2 IP change failure when the encoder and NVR are on different subnets.
