# i3 Partner GiPi Integration Policy

i3 International stands for an outstanding customer experience, and whenever mutually beneficial, will integrate with the third-party IP devices, such as IP cameras, encoders and more.

The determination on whether the integration is approved is made by the i3's management based on the future business potential for i3.

In order to be considered for the integration, the device manufacturer or the end user must supply i3, at no charge with the following:

1. Two (2) samples of the equipment to be integrated for evaluation, testing and subsequent support. The two samples must be of the same product model or must use the same API technology. These units will be retained by i3 International for future regression testing purposes.
2. API documentation for the above equipment.
3. A list of all product models using the same API technology.
4. Your company logo for i3 Partners web page (IP Component Manufacturer only).
5. Engineering contact to address technical issues that may arise from this integration and to provide support, as needed.
6. An Integration Fee of S5,000. This fee, minus S1,000 is refundable only if the integration cannot be completed due to technical issues out of i3's control.

*Note, provided enough ROI exists and the compelling business case for the integration is made by the Requisitioner, this fee may be waived at a sole discretion of i3.*

Scheduling of and allotment of Engineering Resources for the purposes of your IP GiPi Integration will commence once the above requirements are met by the third party requesting the integration.

The sample model (donated product) that has been tested will be identified and listed on our online integration page, followed by the supplied list of the compatible models provided by the manufacturer. The list of compatible models should be updated regularly by the product manufacturer with any new compatible model numbers.
